October 19 - **End of Sale** - Last day of order taking and entering order card sales into M20S. No additional dates for on-line sales.

October 19 - Last day for customers to place online order for girl delivery of nut/candy items.

November 2 - ACH #1 - 50% due to council

November 7 - 17- Nut and candy girl delivery items along with girl rewards will be shipped directly to troop representative.

December 1 - Final ACH - Balance due to council.
