General Summary

The Mission Delivery Specialist II – Camp supports and leads the delivery of high-quality, mission-based programs at Camp Arnaz and other GSCCC program centers. This position builds upon foundational program experience to take on greater leadership in planning, coordinating, and facilitating Girl Scout activities, including equine, archery, STEM, environmental, and outdoor adventure programs.

The Specialist II provides hands-on leadership during programs, ensures safety compliance, mentors newer staff, and contributes to the design of meaningful experiences aligned with the Girl Scout Leadership Experience (GSLE). This role requires initiative, reliability, and a strong commitment to teamwork and youth development.

Essential Job Responsibilities

Program Leadership & Delivery

- Lead and assist in the planning and facilitation of girl-focused, mission-aligned programs and events.
- Deliver safe, engaging, and age-appropriate programming in alignment with GSLE and Safety Activity Checkpoints.
- Serve as lead instructor or assistant in program areas such as equine, archery, axe throwing, STEM, or outdoor skills.
- Support the creation of lesson plans, schedules, and activity outlines for seasonal programming.
- Evaluate program outcomes and provide recommendations for improvement.

- Create a welcoming, inclusive, and positive atmosphere for all participants, families, and volunteers.
- Provide clear communication before, during, and after events to ensure smooth coordination.
- Model the Girl Scout Promise and Law through leadership, kindness, and integrity.

- Maintain program supplies, activity spaces, and equipment in safe and working condition.
- Perform daily setup and cleanup of assigned program areas.
- Support basic maintenance of equine, camp, and activity facilities as assigned.
